Howdy,

You have been cordially invited to the Bandera Chuck Wagon Races, one of the hottest new events in the 'Texas Hill Country, hosted by the 'Twin Elm Guest Ranch in Bandera 'Texas. 'The Bandera Chuck Wagon Races is a sanctioned event leading to the National Finals in Clinton, Arkansas, Labor Day weekend, and the only qualifier in 'Texas!

GROUNDS: Held at the Twin Elm Chuck Wagon Racing Grounds
located at: **810 FM 470, Bandera, Texas 78003**

ELIGIBILITY: This venue is open to individual artists and craftsmen; a select number of manufactured, imported or resale items will be allowed in the venue. Demonstrating your art, craft or product, while not required, will be a consideration when booths are being assigned. To maintain the quality and variety of this show, this will be a juried craft show. The Twin Elm Guest Ranch reserves the right to reject any display that is not in keeping with the examples submitted.

EVENT: The Bandera Chuck Wagon Races will be held on Saturday May 14th and Sunday May 15th, 2011. Hours of operation are from 10:00 AM until 5:00 PM Saturday and Sunday. Vendors must be completely set up and vehicles moved to the appropriate parking locations **NO LATER THAN 10:00 AM**. Information regarding entrance and parking will be included in your letter of acceptance to the event.

REGISTRATION: The booth fee is \$100 (\$50 per day) and \$150 for food (\$75 per day) due at the time you turn in your application. ***We ask that you give us a 24 hour notice if you will not be able to make it.*** There is an additional opportunity available to set up Friday night for the Rodeo at an alternate location for a nominal fee. SPACES: Open spaces *only* are provided and will be 10'x10'. You provide your own canopy. If you plan to use a canopy, tent, umbrella, please specify and give dimensions. There will be a limited number of spaces available. **Electricity will be available on a limited (first come, first served) basis for \$10**, or you are welcome to bring a (quiet) generator. Please contact the Event Coordinator for more details.
